**NOTICE IS HEREBY GIVEN** that, pursuant to U.S.C.R. 20, the Court will conduct a Call of the Calendar of pending civil actions in which the discovery period has expired, at 11:00 A.M. on the 12th day of February, 2018, in **Courtroom No. 1 of the Thomas County Judicial Center**, Thomasville, Thomas County, Georgia.

Those attorneys or pro se parties receiving this Notice have one or more cases pending in Thomas County State Court. To determine in which cases announcements need to be made, a copy of the calendar may be viewed at the Thomas County Clerk of Court's website:

All counsel and pro se parties having cases appearing on said calendar are required to attend said Calendar Call at the aforesaid time and place to announce whether the cases listed on said calendar are ready for trial, and, if not ready, to state the reasons therefore. In lieu of making such appearance counsel may make such announcements in **writing** no later than (2) business days before the date and time scheduled for said Calendar Call. Any written announcements received after this deadline will **not** be considered. Announcements by telephone will not be accepted at any time. Counsel shall specify the name of the parties and the civil action case number. Counsel shall also indicate whether or not a jury trial has been demanded, if a pre-trial conference is requested, and whether a court reporter is required for the trial of said case. Parties announcing **ready** should also give an estimate of the time required for the trial of said case. Announcements should be sent to:

Announcements must indicate which side counsel represents if the announcing attorney is not the attorney of record listed on the calendar. Failure to appear at said Calendar Call, or to make announcement to said Judge may, in the Court's discretion, subject the offending counsel or pro se party to the sanctions provided for in subsection (A) of U.S.C.R. 20. **Trials on cases placed on the Ready list shall be held commencing on Monday, April 16, 2018.** Whether a case shall be placed on the Trial Calendar shall be solely within the discretion of the Court, despite what announcement is made at Calendar Call (U.S.C.R. 8.1). No action will be continued merely by agreement of counsel (U.S.C.R. 8.5). If a case is not listed on this calendar and all parties agree that the case should be placed on the trial calendar, counsel or pro se party may contact the Clerk's office to add the case to the calendar call.
